

## Cast your vote!



Voting has opened in this year's contested elections for InternetNZ Council, President and Vice President positions. With the evolving influence and workload of the Society, the selection of Councillors and Officers is critical and there are significant constitutional amendments to vote on as well.

With buoyant membership numbers following from initiatives around telecommunications reform and copyright, as well as profile-raising of the Society at events such as Convergence Oceania, turnout could reach a near-record high if all members exercise their vote. Every member has an equal vote regardless of whether they are individuals or representing organisations.

It is easy to vote using InternetNZ's online voting system. Members will have received an email with a link. And because it is a preferential voting system, there is confidence your vote will count.

## InternetNZ supports Open Source Awards

InternetNZ has lent its support to the upcoming New Zealand Open Source Awards by agreeing to sponsor one of the award categories – Open Source Use for Community Organisations. The awards recognise the contributions of New Zealand individuals and organisations to open source projects.

InternetNZ has long supported open source, as it plays a key role in the vision of an open and uncaptureable Internet.

InternetNZ president Colin Jackson says the Internet and open source are joined at the hip. “Much of the Internet is built on open source software, particularly in the areas of web servers and other key infrastructure software components. Also, most open source projects rely on the cooperation of teams of people working across the Internet.”

Other categories in the Open Source Awards include best use of open source software in government, business and education. The awards, being run by CatalystIT and The New Zealand Open Source Society, will be held in October with nominations closing on August 17. Details at [www.nzosa.org.nz](http://www.nzosa.org.nz).

## Anti-spam activity ramps up

Public consultations closed in June for the ISP Spam Code of Practice with ultimately six being received. The working group involving InternetNZ, the Telecommunications Carriers’ Forum and the Marketing Association will meet in July to consider the submissions.

A further initiative involving the Marketing Association and InternetNZ is looking at a Marketing Association accredited whitelist, where member businesses would be able to be certified as responsible marketers, with that status able to be taken into account by Spam filters. Certification would require compliance with the law and the following of best practice opt-in principles.

Meanwhile the Department of Internal Affairs, the enforcement agency for the Unsolicited Electronic Messages Act, is embarking on a communications strategy to educate business and consumers, starting with a website at [www.antispam.govt.nz](http://www.antispam.govt.nz).

Brochures and a roadshow are being planned to educate business users about when their email marketing activities would be considered Spam, as defined in the law.

## Tel Con 8

The end of June saw the second of the big annual conferences for the telecommunications industry, with an impressive lineup of speakers appearing at Tel.Con.8 in Auckland. The conference dealt with regulatory issues and with the technological changes that are driving convergence in the industry.

Chaired by Michael Wigley, the conference heard from David Cunliffe on what comes after LLU, and from Osmond Borthwick of the Commerce Commission on the regulator’s perspective.

Staff from the major telcos were followed by a presentation from Pete Macaulay on the future of the Digital Strategy. There were a range of other speakers including David Stewart from OFCOM, the UK regulator, and Ernie Newman of TUANZ on the roll of fibre in future.

Jordan Carter and David Farrar attended to represent InternetNZ, with Jordan speaking in a panel discussion of users’ interests in the industry. He made the point that regulating for fibre is not an option – that the regulatory framework can give equality of access to existing bottleneck assets, but that the commercial drivers for a nationwide fibre access network rollout simply aren’t visible today.

The conference gave a good opportunity to talk with other industry participants about the progress that has been made since last year’s “stocktake” announcements in the telecoms area, and where New Zealand goes next to build the world class telecommunications infrastructure the country needs.





## Davidson attends international meetings

In June, InternetNZ Executive Director Keith Davidson represented the society at the following international meetings:

- APTLD Members and Board Meetings - Dubai
- CENTR General Assembly - Helsinki
- VON Conference - Stockholm
- ICANN - Puerto Rico

First stop was the emirate of Dubai for an APTLD meeting (the Asia Pacific Top Level Domain Association). Over 20 ccTLD representatives (Country Code Top Level Domains) attended to discuss a range of technical and policy issues including IDNs (Internationalised Domain Names).

Davidson then travelled North to Helsinki, where he gave a presentation to the CENTR General Assembly (Council of European National Top Level Domain Registries).

The VON conference in Stockholm followed; a three-day VoIP trade show with workshops on issues including peering and ENUM. The term “peering” appears to be equally undefined in Europe as it is in New Zealand, says Davidson. “Peering seems to mean what the person wants it to mean, rather than any formal description or accepted principles.”

From there, Davidson travelled to ICANN’s Puerto Rico meeting. The meeting, held at a beach resort in San Juan, saw the ICANN board post a resolution encouraging take-up of IPv6 by global internet registries. Concerns about security threats such as denial of service attacks were also raised at the ICANN meeting and this will be the major issue for the next ICANN meeting in Los Angeles in October.

For the ccTLD community the main issue on the Puerto Rico agenda was IDNs (Internationalised Domain Names) for ccTLDs. This occupied a full day of meetings and Davidson says there was strong empathy for APTLDs’ position seeking rapid deployment of a single IDN where the ccTLD manager and government agree on a recognised non-Latin language script. “This would give countries like Japan, Taiwan and Korea a useful start in resolving domain names in their native language,” he says.

Also discussed was ICANN’s geographic regions, which are an issue for many ccTLDs on the boundaries of different regions. “It seems probable that the ICANN community will agree to the concept that the ccTLD manager, if approved by their government, can choose which region they should belong to.”

## NZ gears up for IPv6

A core component of New Zealand's Internet infrastructure is being geared up to accommodate huge potential increases in the number of networked devices connected to the Internet. The key to increasing capacity is the introduction of IPv6, the next generation Internet Protocol. IPv6 uses 128 bits for its computer addresses, a huge leap from the 32 bits used in the existing IPv4. This means 340 billion billion billion addresses can be covered by IPv6, compared to 4.3 billion for IPv4.

The .nz name servers in Wellington and Albany are now operating with IPv6 connectivity in what can be regarded as the first phase of the .nz IPv6 rollout. Both are connected to the NZ IPv6 Internet Exchange and there is a .nz Whois server accessible at [whois.ipv6.srs.net.nz](http://whois.ipv6.srs.net.nz).

### InternetNZ and KAREN – IPv6 Workshop

Philip Smith (Cisco) and Gaurab Upadaya (Packet Clearing House) have kindly agreed to deliver their five day IPv6 Workshop in NZ. This workshop has been delivered at several APRICOT / APNIC / SANOG meetings in recent years. Philip and Gaurab are experienced, world-class instructors on IPv6. The lab equipment consists of 28 Cisco routers and switches.
